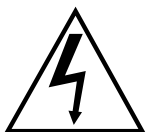

6. CLEAN ONLY with dry cloth.

VOLUME CONTROL

The SoundBar comes with convenient volume control options through both HDMI and Bluetooth technology. This allows users to easily adjust the volume of their sound system using either connection method, providing flexibility and ease of use for a seamless audio experience.

HDMI

- Volume control is managed through CEC control from the TV.
 - Adjusting the volume of the TV and the soundbar will follow the change in volume.

Bluetooth

- Volume control is managed through the connected Bluetooth device.
 - Adjusting the volume on the Bluetooth device and soundbar will follow the change in volume.

- There are no volume buttons on the soundbar.
- No remote is included with the soundbar.

BASIC CONNECTORS AND INDICATORS

To connect the soundbar to your local source device, simply plug the HDMI input port into the HDMI output of your device.

Connectors

- HDMI Input
 - Connect the input port to the HDMI output of your local source device.
- HDMI Output/ARC
 - Connect the port to the HDMI Input with ARC support on TV.
 - Verify the TV has ARC enabled and verify TV is set to 2 channel PCM.

Once these steps are completed, power the soundbar by connecting the included power cable to the connector.

If you want to connect the soundbar to a Bluetooth device, simply press the button short or long to set the input to Bluetooth and enter pairing mode.

Finally, the soundbar has an Auto-Standby feature that will enter standby mode after 18 minutes of no audio activity.

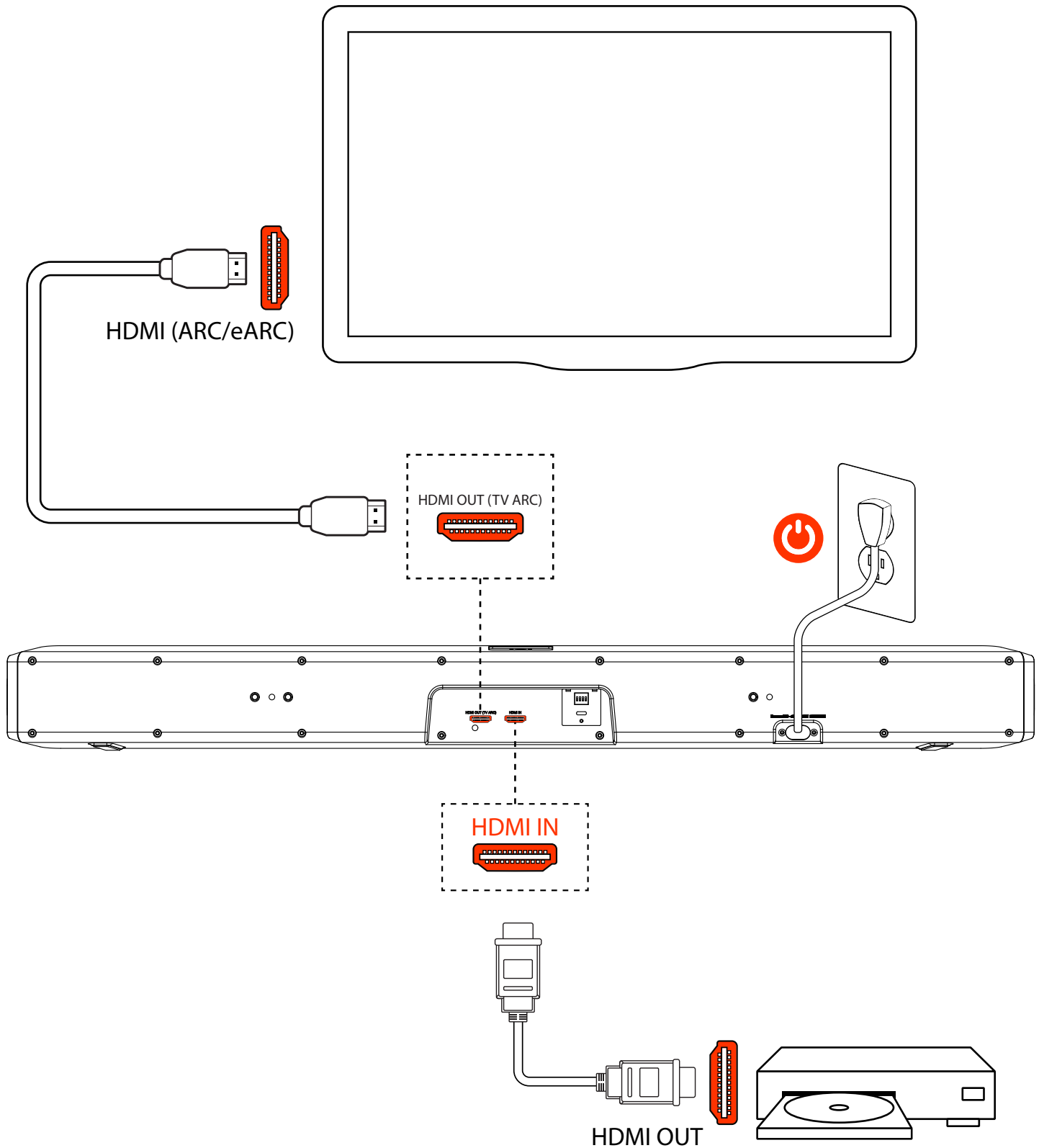
Power

- Connect the power cable (included) to this connector.
- HDMI input
 - Soundbar will turn on/off via CEC commands from the TV.
 - If an on command is sent the soundbar will change to HDMI input.
 - Note – Full compatibility with all HDMI-CEC control is not guaranteed.
- Bluetooth input
 - Soundbar will be turned on by pressing the multi-function button on the top of the soundbar.
 - › If the button is short pressed while the soundbar is standby the input will be set to Bluetooth.
 - › If the soundbar is on and HDMI, it will change to the Bluetooth input. If the soundbar is on and Bluetooth it will change to HDMI.
 - › If the button is long pressed for 3 -9 seconds, the soundbar will wake change input to Bluetooth and go into pairing mode.
 - › If the button is long pressed for 10 or more seconds, the soundbar will wake change input to Bluetooth clear all prior pairings and go into pairing mode.

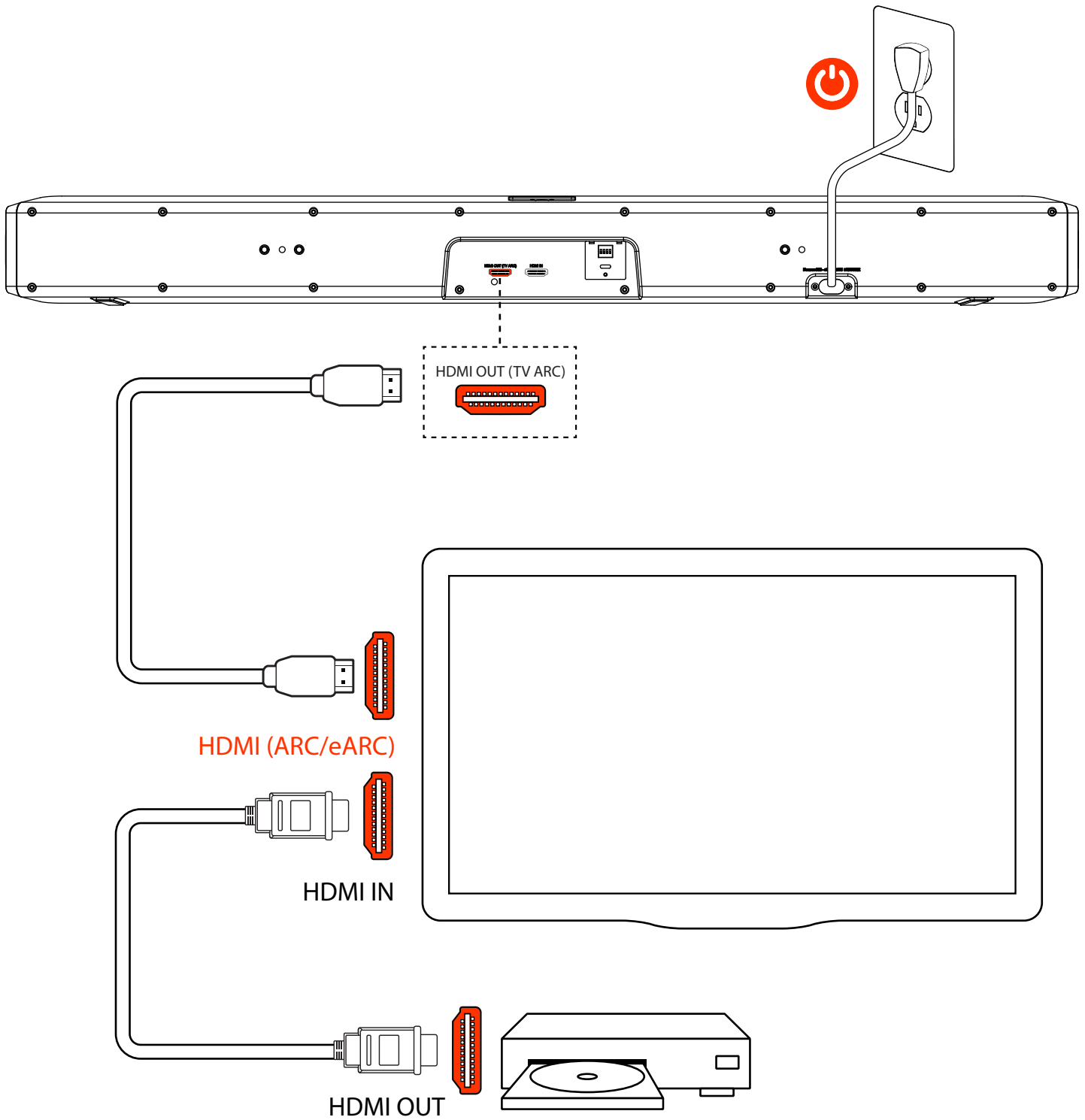
HDMI Passthrough

- Connect playback device HDMI to soundbar.
- Connect soundbar to HDMI input on TV.



HDMI ARC

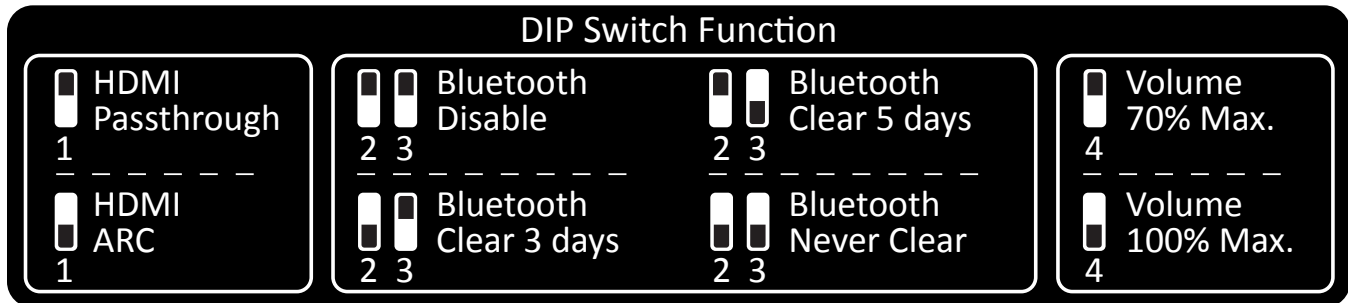
- Connect playback device to HDMI input on TV.
- Connect soundbar to HDMI input with ARC support on TV.



INSTALLER SETTINGS

This section contains advanced settings intended only for the installer. Once the appropriate settings are chosen, the Rear Security Plate (included) can be installed with a screw (included) to prevent end-users from tampering with these critical settings.

Dip Switch Functions



(Sticker on back of soundbar)

- Dip switch 1 controls HDMI audio
 - On
 - Audio will be expected from the HDMI Out/ARC port.
 - Off
 - Audio will be expected from the HDMI Input port.
- Dip switch 2 & 3 control Bluetooth
 - 2 On – 3 On
 - Soundbar will never clear prior pairings with Bluetooth devices.
 - › Useful for installations where the user is the same repeatedly.
 - 2 On – 3 Off
 - › Soundbar will clear prior pairings 3 days or older.
 - Useful for installations where users don't expect to stay more than a few days in the same space as the soundbar.
 - 2 Off- 3 On
 - › Soundbar will clear prior pairings 5 days or older.
 - Useful for installations where users expect to stay for more than a few days in the same space as the soundbar.
 - 2 Off – 3 Off
 - › Bluetooth is disabled.
 - Multi-function button on top of soundbar will not change inputs to Bluetooth.
 - Recommended to install the top security plate.
- Dip switch 4
 - On
 - › Volume is not limited.
 - Off
 - › Volume is limited to 70% of max volume.

TOP PANEL

Single multi-function button.

- Soundbar on – Bluetooth enabled.
 - Single press changes input from HDMI to Bluetooth
- Soundbar on – Bluetooth disabled.
 - Nothing.
- Soundbar off – Bluetooth enabled.
 - Wakes soundbar from sleep and changes input to Bluetooth
- Soundbar off – Bluetooth disabled.
 - Wakes soundbar from sleep and changes input to HDMI.
- 3-Second-long press - Bluetooth enabled.
 - Soundbar goes into Bluetooth Pairing mode.
- 10-Second-long press - Bluetooth enabled.
 - Clears all prior Bluetooth pairings.

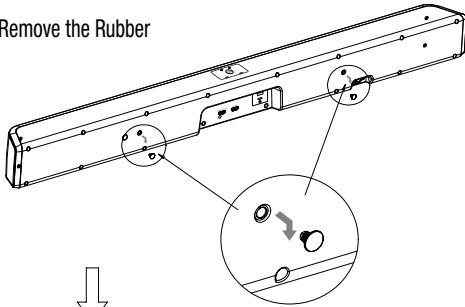


Tighten the bracket on the table using 4 X M4 screws (the distance between two brackets should be 406mm (16 inches)).

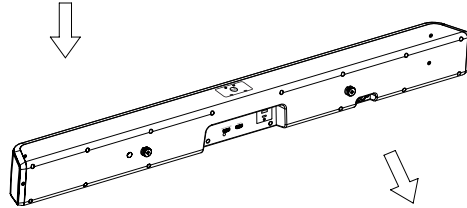
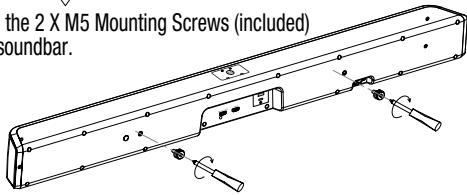

	HDMI Source <ul style="list-style-type: none"> Verify HDMI dipswitch is set to the corresponding method of HDMI audio used with the installation. <ul style="list-style-type: none"> If HDMI Input is connected HDMI dipswitch should be turned off. If HDMI Output/ARC is where the audio is coming from HDMI dipswitch should be turned on.
	Bluetooth Source <ul style="list-style-type: none"> Verify Bluetooth dipswitches is not set to Bluetooth disabled – 2 Off, 3 Off. Ensure Bluetooth device is paired and outputting audio to Soundbar.
Soundbar is too quiet.	Verify the max volume limiting dipswitch is set to the correct setting for the installation.
	Adjust volume via TV when using HDMI input and Bluetooth device when using Bluetooth input.
Soundbar won't pair with Bluetooth device.	Verify soundbar is on Bluetooth input.
	Verify soundbar is in Bluetooth pairing mode by holding the multi-function button for 3 seconds.
	Verify Bluetooth device is in pairing mode.
	Ensure Bluetooth beacon displays and matches the soundbar setting.
	Hold multi-function button for 10 seconds to clear and reset Bluetooth pairings.
