This decision is subject to verification of defect or malfunction upon return of product to NONSTOP or its authorized distributor. All replaced parts and product become property of NONSTOP and must be returned to NONSTOP or its authorized distributors. Replacement parts and products assume the remaining original warranty, or ninety (90) days, whichever is longer.

Proof of purchase (original bill of sale) including purchase date is required and must be presented upon request. This limited warranty begins on the original date of purchase, and does not include transportation, installation, removal or reinstallation.
